#### Using the Software

Important: Before making changes to one or more pages / articles, please make a backup of them (copy them to another location). Using the software is really easy. First, Open the software and select an option depending on what you want to do. Add Legal Pages to Website Add Legal Terms to Articles (.txt) Close App

The first option, allows you to add legal pages to a local HTML page (like an .html or .htm sales page that you've got from a product with resale rights etc).

The second option, allows you to add legal terms to .txt articles in bulk (if you have 100's or 1.000's of PLR articles and you want to add legal terms to them, you can easily do it with this tool + you can also use it to add affiliate links to them).

Here you'll get an HTML code that you need to add to the Home Page of the Website that you're modifying (in general, this page is named as "index.html" or "index.htm").

This code will link your "Home Page" with the legal pages that The software has just created. The good news is that the software will do this for you.

Just select the filename that belongs to the home page of the website (in general, index.htm or index.html) and click "Add Links to Home Page".

That's all.

Comment: The software inserts the HTML code (with the links to the legal pages), below the "</body>" tag. If this tag is NOT present in your HTML page, then there's something wrong with it.

If this happens (or if you want to insert the links in another section), Then you need to manually edit your HTML page (with a text editor like Notepad or Notepad ++) and add the code in the section of your choice.

# Addding Legal Terms to Articles

If you want to add quick disclaimers to your .txt articles (PLR articles etc), Then this tool will surely help you.

To get started, just select a folder with .txt articles.

If you want to add affiliate links, you can enter the details here (links Will be added with HTML format, in case that you later want to upload these articles to a website or blog).

If you don't want to add affiliate links to the articles, just uncheck the first 2 options ("Add recommendation...").

To add one (or more) legal disclaimers to your articles, just click "Add Legal Disclaimers to Articles"... And select the terms that you want to add.
